

North American Architectural Woodwork Standards Committee Use, Copy, Partial Reproduction Third Party Licensing Form

To facilitate the adoption, use and ongoing relevance and enhancement of its standards publications and derivative works, the Sponsor Associations - the Architectural Woodwork Manufacturers Association of Canada (AWMAC) and the Woodwork Institute, in conjunction with the North American Architectural Woodwork Standards Committee (Committee), encourage third party use, copy, or partial reproduction of its copyrighted materials.

After fully executing and submitting to the NAAWS Committee Secretary, the below form, the NAAWS Committee will review, consider and if approved, grant third party use, copy or partial reproduction (without alteration) specific part(s) of its copyrighted materials.

Requests will be placed on the Committee's next meeting agenda and acted on during its normal course of business, as time permits. Decisions of the Committee will be provided in writing by the Committee Secretary. If a decision is not reached at the first meeting wherein the item was added to the agenda (or subsequent meetings) the Secretary shall inform the requesting party of the status of the process.

If permission is granted, I/We acknowledge and agree:

- that permission for use is limited to the applicant's current documents' edition
- that intended end use will deliver factual information, education, and promotion of architectural woodwork
- that permission may be revoked for improper use, distortion of the status and integrity of the cover image, or use in violation of this policy
- to credit the *North American Architectural Woodwork Standards* and Sponsor Associations as the original source of the referenced material, by using the following phrase:

"Reprinted with permission of the North American Architectural Woodwork Standards Sponsor Associations: AWMAC and Woodwork Institute."

- to furnish the NAAWS Committee a copy of all documents in which the materials are used
- For Cover use, copy or reproduction:
