- That the NAAWS Committee may rescind the right to publish or distribute the derivative translation work, if the NAAWS Committee finds that it leads to confusion regarding the original document's status or integrity.
- To ensure a faithful translation without any normative changes.
- To share constructive feedback on the source document, insights on clarity and consistency are valuable to the NAAWS Committee.
- To notify the NAAWS Committee when the translation is completed and provide both printed and digital archive copy(s) of the translation, including any updates to the translation.
- That digital translations may be republished and distributed by the NAAWS Committee and its sponsor Associations.
